3	If the tax payer is not convinced with the decision of the Sub County Revenue Task Force Committee, the tax payer appeals in writing to the District Revenue task force committees
4	The District Local Revenue task force committee sits to review the decision of the Sub County Revenue Task Force Committee
5	If the tax payer is still not convinced with the decision of the District Revenue Task Force Committee, the tax payer is at the discretion to appeal to any competent court.
